Shan: St. Joes reached out because they wanted to sponsor, but they are not a paid ad sponsor.

6:10 Steve Ellison: the longer we wait to work on the ads for the book, the longer it takes to start on it.

Shan: I'm not going to turn someone away that we didn't already have on our list. Steve Ellison: That is fine, but if we start getting ads after we have started working on the book, that will bump the deadline.

Shan: What I'm getting is from you Steve Ellison is that at this point, we can't add anymore sponsors?

Steve Ellison: I'm not saying we can't add anymore, but it's going to require a designer to go back and add an ad to each page.

Jamie: When do we need to have all of these in.

Steve Ellison: The designer said by next Wednesday January 18th.

Jamie: That's not going to happen, we have given our sponsor until January 31st. Steve Ellison: And I told them that. Ideally, we would need the info by the beginning of January, so we have two weeks to search for the sponsors.

Jamie: Can you let us know soon, we have another vendor that could go up there.

Charlotte: Don't let it go yet, we will find out soon.

#### **SUPERINTENDENTS**

- 6:31 Nicole: Horse we have a judge Brien Niece, Brad will be doing our gaming judging as normal. We are working on getting a round robin judge. May 13th and 14th is the horse show. We have over 30 kids this year, which is the most that we have had in six or seven years.
- 6:33 EJ: Before I talk about pigs I want to confirm with you guys that I have the fairgrounds for the clinic on the 1st and 2nd of April.

Shan: Yes.

Peggy: Did you contact Janice

EJ: I talked to her, but she said she didn't know anything.

6:35 EJ: My next question is, I have some kids that are coming in from the middle of the state and the other side of the state. Their parents are wanting to know if they can rent camper spots.

Jamie: How many days?

Shan: Our regular date is \$15 per day.

EJ: Now the pig weigh in concerns. We have a lot of parents and leaders that are concerned about weigh in that is coming up in two weeks. We have 30+ pigs that are on antibiotics and 4 that have died already. We have reached out to the sales committee. We have talked to Warren before the sales committee meeting. What can we do to stop this weigh in.

6:37 EJ: Lewiston Vet is saying that this is not a good idea. Dave Rustabakke has reached out to Missy and they both agree that this is NOT a good idea to have this weigh in. Chance will speak on being in contact with the state vet. This is an upper respiratory infection, and it is contagious.

Nicole: This is more than just a weigh in and tagging. The sales committee would have to change their clothes, sanitize the areas. Missy reached out to Warren and advised against it prior to the sales committee meeting.

6:39 Chance: It is not a good idea. Before EJ reached out to me, I was in the process of putting info together. I have been working on this for three weeks before anyone called to talk to me. Walla Walla has not done a pre-weigh in in 10+ years. They use a form; the leaders tag the pigs and it's over with. I'm not sure what the sales committee has on continuing to do the weigh in. It doesn't affect the rate of gain.

Jamie: Warren said that it's a way to see if a kid is taking care of their animals.

6:41 Chance: If they are worried about the well-being of a pig, they wouldn't have a weigh in. Everyone I have talked to said in the end do not commingle pigs from all over the area and expect an outcome without all of the pigs getting sick.

Nicole: We learned this in COVID, if we are going to have a superspreader event then we need to take the precautions. I like the idea of doing a form, a tagging and sending pictures, because unfortunately there are people that may not be truthful about tagging their pigs.

6:43 Chance: I think it is best for whoever the pig leader is, to disinfect between each visit. I am sure the sales committee is going to be involved.

Nicole: The sales committee is not interested in doing that.

6:45 EJ: the numbers at this weigh in are a concern, that can be brought up later. You push your pig weight to 150 and then start making holds.

Chance: I would like to know what our plan is. I am not going to take my kids pigs to a

weigh in and bring them back to where my sows are housed.

6:47 Nicole: I know that this is something we need to look at. I think we can help dictate where we go from here. We have to have a solution to this issue. Weigh in is only a couple of weeks away. Horses get it, lambs get it, it's not just pigs. My suggestion would be we have 4H leader's tag.

EJ: We can reach out to Walla Walla and ask if we can get their form from them.

6:48 Chad: If I was the sales committee, I wouldn't want to be held responsible.

Jamie: they said they can't prove that the pig got sick from that.

Peggy: Is there a way to get leaders to send me an email of how they feel about it.

EJ: I called every leader last night and have a list of how many pigs are sick, how many passed away, and every leader is against it.

Shan: We have vets reaching out to us saying this is a bad idea.

Nicole: Missy was shocked after her conversation with Warren. She could not believe it.

6:52 Chad: Does the extension office have any guidance or input.

Janine: Mark talked to them and told them he was against it due to a biohazard issue.

Chance: there will be well over 200 pigs going over that scale.

6:53 Jamie: Chris can we get your opinion.

Chris Seubert: I am going to stay out of this one.

Chris Seubert: EJ called me today and I told him I was going to look into it.

Jamie: What if the Fairboard decides to lock the gates so nobody can get in.
