Treasurers Report- \$124,661.13 in account now including the loan we took out. Loan was for \$105000. Rodeo insurance came in at \$1007.00

Style Review- April 17th at 7pm. Tara is needing a judge. Peggy said she would be willing to judge. Nicole said she would let Tara know. Jeanene said Tara was also looking for people to hand out awards. Nathan said he could go and hand out awards. Shan said Abby could help do ribbons and trophies too.

Rodeo- Chutes have been started, kids rodeo entries are live on the web site, removed the concrete tables on the upper level and ordered new ones. Steve said the animal rescue sled should be here soon. Fence work will begin on Monday. Chad spoke with Toyota today and they will supply a car for the parade. Tom said he is willing to do grand entry in the back of a pickup and be driven through the parade.

Loan- received the loan from the county to pay the Invoices for the Department of Ag Grant. Once we receive those monies back, we will pay the loan back.
