I hereby release Asotin County, Asotin County Fairboard, Royalty Coordinator, and Royalty Chaperone from responsibility of injury or loss to person or property involving myself related to my appearance in the Royalty tryouts and subsequent reign; this also applies to people related to me.

I hereby certify that I have never been married, pregnant, or given birth to a child.

I hereby release title, claim, and rights to photographs, and/or public relations materials involving myself to the Royalty Coordinator/Fairboard for use in tryout promotion.

The decision to be considered for an opportunity to tryout again will be at the discretion of the Asotin County Fairboard and Current Royalty Coordinator.

On behalf of the Royalty Coordinator & Fair Board, we welcome your participation in the 2025-2026 Royalty Tryouts, **Mandatory royalty contestant and parent/legal guardian meeting, which will be held at the fairgrounds in the Fair Office-Lower Level, date and time will be scheduled once application has been turned into Peggy Hansford. Royalty tryouts will be on Saturday, October 4th, 2025, at 11am** at the fairgrounds, Interview's will be first and then riding.

Parent(s)/guardian(s) support. Parent(s) and/or guardian(s) should be prepared for a private interview with the Judges and Royalty Committee.

Asotin County Fair and Hells Canyon Rodeo Royalty Rules and Regulations

1. Candidates must be at least **14 years of age as September 13th, 2025**, but no older than **20 years of age as of October 3rd, 2026**. A birth certificate may be requested.
2. Royalty Candidates must live within the boundaries of the following Counties: Asotin, Garfield, Columbia, Walla Walla, Whitman, Nez Perce, Latah, Idaho, Lewis, Clearwater, and Wallowa.
3. Candidates must be single, never have been married, pregnant, or given birth to a child, nor committed any crime and must agree to remain so for the duration of her reign.
4. Candidates shall not live with their boyfriends/significant other and must agree to remain not living with them for the duration of their reign.
5. Candidates must be honest and dependable with good moral standards and integrity.
6. Candidates must not have engaged in any act, which if made public, would be likely to cause harm or damage to the candidate's reputation or to the goodwill and reputation of the Asotin County Fair and Hells Canyon Rodeo or Royalty Program. Any concerns about the applicability of this provision should be discussed with the Royalty Coordinator prior to signing the application.
7. If a person has already held the title of Asotin County Fair and Rodeo Queen, they cannot try out for future Asotin County Fair and Rodeo Royalty Courts.
8. Candidates that have been previously dismissed, disqualified, or resigned from the Asotin County Fair and Hells Canyon Rodeo Royalty program, and would like to be considered for an opportunity to compete in FUTURE Royalty tryouts, must submit a request to the Asotin County Fairboard. The Decision to be considered for an opportunity to tryout will be at the discretion of the Asotin County Fairboard and the Royalty Coordinator.
9. Candidates must have reliable transportation for themselves, or parent/guardian can drop off & pick up.
10. **Court duties must come first please**, throughout the season, before work, school events, or other events or family vacations. Excused absences must be approved by the Royalty Coordinator
11. Girls on the court may not compete for or hold any other honorary positions that will interfere with the Royalty Court activities.
12. Candidates must conduct themselves in a professional, courteous manner and portray high moral standards. Candidate will not be permitted to drink alcoholic beverages, use any tobacco products, or use foul language at any time during the tryout and/or during their reign.
13. All Royalty funding & spending will be at the discretion of the Royalty Coordinator and Fairboard. Tryout winners will be required to go out and ask for donations for the fair, rodeo, and royalty fundraiser. Tryout winners and their families will be required to help with decorations, set up and take down at the fundraiser.
14. Candidates must provide their own clothing for tryouts, interviews/speech, and riding portions at the tryouts.
15. From the time the Tryouts begin and throughout the Asotin County Fair & Hells Canyon Rodeo Royalty reign, Royalty and parents/guardians must respect the Royalty Coordinator, Chaperone, Fair and Rodeo members, judges, volunteers, and fellow candidates, and conduct themselves in an appropriate manner at any time during tryouts and during their reign. Any candidate or parent/guardian failing to do so will cause automatic **disqualification / dismissal** and the contestant will forfeit any prizes or titles to be awarded to her.
16. Judges and Royalty Coordinator have the final say on all scoring decisions. During the Tryout or any Tryout-related functions, there may be a silent judge(s) present. Any individual with the intent to influence or harass a judge or candidate will be subject to disqualification.

17. Tryout winner(s) and their parent(s) and/or guardian(s) will be required to sign a contract for the year of reign and abide by its rules. A copy of the contract is included in this packet for your review.
18. The tryout winner(s) must attend rodeo, parades and any social & civic events selected by the royalty coordinator. The royalty coordinator will prepare a royalty event schedule. Great care will be taken in providing as much advanced notice of an event change or event add on. Please keep in mind that some event invitations are received with short notice. The chaperone or royalty coordinator will contact the parents/guardians as well as the royalty member of any changes or additions to the royalty schedule. We will try our best to give at least 48-hour notice of the changes or additions to the schedule.
19. Royalty Members and their horses must all travel together with the Chaperone/Royalty Coordinator in the county truck & horse trailer when going to royalty events. Parents/guardians are responsible for their own travel and expenses to & from royalty events.
20. Candidates must be prompt and on time to all functions. Please plan ahead.
21. Royalty members may not attend any event without their chaperone or a royalty coordinator while representing the Asotin County Fair & Rodeo.
22. Any candidate being coached by the audience members during tryouts will be subject to disqualification.
23. I understand that if I am selected for the title of Asotin County Fair & Hells Canyon Rodeo Royalty, I will be an official representative and be responsible to represent the Asotin County Fair & Hells Canyon Rodeo in a professional manner. I will strive to represent sportsmanship, high moral and ethical character and humane treatment of animals.
24. I understand that the Asotin County Fair & Hells Canyon Rodeo Royalty Program is not a beauty contest. Rather, it is a competition that recognizes several attributes (i.e., public speaking, personality, and appearance, maturity). Therefore, it is my responsibility, as Asotin County Fair & Hells Canyon Rodeo official representative, to act, speak and dress according to the esteem my title deserves anytime I am in the public eye. Public speaking is an essential part of the position of royalty and, as such, I will continue to grow in my public speaking abilities to professionally represent the Asotin County Fair & Hells Canyon Rodeo.
25. I understand that if I am selected for the title of Asotin County Fair & Hells Canyon Rodeo Royalty, I will have to return the Fairboard property of the royalty pass down items. Such as the serape, name tag, etc. A Full list will be given out to the tryout winners.
26. I understand that during official Asotin County Fair & Hells Canyon Rodeo Royalty activities, a chaperone will be designated for me and that I will abide by my chaperone.
27. I agree that during the term from my entry as a candidate and through my reign as Asotin County Fair & Hells Canyon Rodeo Royalty, I shall remain unmarried and shall observe a high standard of moral and ethical behavior befitting my title and set a good example to the public, to future competitors, and the Asotin County Fair & Hells Canyon Rodeo Royalty Program.
28. If I possess a personal website, social media account, or profile (i.e., Facebook, Twitter, Instagram, Snapchat etc.), I agree that all material contained therein will be maintained to reflect a positive image of me, and the fair & rodeo, and I will not participate in, nor promote any form of bullying throughout my reign representing the Asotin County Fair & Hells Canyon Rodeo Royalty.

29. I agree that the Asotin County Fair & Hells Canyon Rodeo Royalty commitment will be my priority over any other activities such as family vacations, holidays, camping trips, rodeo, school sports, softball, track etc. that I may be involved in throughout the year of my reign.
30. I understand that it is my responsibility to go out with my chaperone/Royalty Coordinator and contact business and obtain donations for the Asotin County Fair & Rodeo Annual Fundraiser. I will receive a list from the Fairboard of the business I will need contact. I also understand I can add other businesses to the list with Fairboard approval.
31. I agree to follow the chain of command if any issues arise: The chain of command is as follows: Chaperone, then the Royalty Coordinator, then The Fairboard, If I cannot get resolution at any of these steps, then I would need to inform the Fairboard President that you would like to move on to the next step.
32. Be on time and attend all events as requested by the Royalty Coordinator and Chaperone, and be prepared to promote the Asotin County Fair & Hells Canyon Rodeo
33. Be fully dressed in Royalty attire, as assigned, before arrival to an event (unless other arrangements have been made by the Royalty Coordinator).
34. Make sure clothing is kept clean and pressed and any hats are neat and clean, for all appearances.
35. Good hygiene, bathe before each event. Keep fingernails clean and manicured with polish recommended by chaperone or royalty coordinator.
36. Be careful when choosing attire when not in uniform, remembering I constantly represent the Asotin County Fair & Hells Canyon Rodeo.
37. Agree to sign a contract with the Asotin County Fair & Hells Canyon Rodeo with respect to my duties as Asotin County Fair & Hells Canyon Rodeo Royalty.
38. Uphold the title of Asotin County Fair & Hells Canyon Rodeo Royalty while fulfilling the provisions of my reign.
39. Encourage others to participate in future Tryouts, act as a hostess to contestants in future Tryouts, and assist in the promotion and conduct of the Tryout in every way.

Tryouts (Candidates will be chosen to Represent the Asotin County Fair & Hells Canyon Rodeo-This will be Determined by Royalty Coordinator & Fairboard, and Judges)

There will be one or more judges. In case of a tie, the same question will be asked to all candidates, the candidate that answers the question correctly and receives the highest score will be Queen. Each contestant will be judged in interview, speech presentation, impromptu question, & modeling (if you need additional information on modeling contact Peggy Hansford 208-791-1451). There may be other activities deemed appropriate by the Royalty Coordinator or Judges. Criteria within each major area of judging include the following:

Interview Division

Appropriate apparel for Interview: Dress or Knee Length Skirt with Long Sleeve Western Shirt.

The purpose of this division is to select the young woman who scores the highest in:

1. **Application:** Information, appearance, grammar, and spelling.
2. **Intelligence and knowledge of:** The Asotin County Fair & Hells Canyon Rodeo, Events, Dates, Exhibitor Handbook etc.
3. **Conversational abilities:** The ability to answer questions in a confident and thorough manner and proper use of the English language.
4. **Showmanship:** The ability to present herself in a gracious manner and demonstrate the ability to promote the Asotin County Fair & Hells Canyon Rodeo in public events as our Royalty spokesperson.

Personality and Grooming

- General: Personality, attractiveness, poise, and proper behavior.
- A tie breaker in overall tryout scores will be settled by taking the highest score in the Speech category.
- Grooming: Appearance must be neat; cleanliness is expected in every detail. (hands, hair, nails, fragrance, and clothing)
- Fashion Sense: Outfits should be fashionable and tasteful clothing. Outfits should be proper for the occasion, coordinated and enhance the natural coloring and figure of the candidate. Meticulous care and condition of clothing worn is expected. Royalty Committee has final say of contestant's selected clothing.
- Posture and Poise: Candidates should stand tall and project self-confidence and poise. Grace and dignity are expected in all situations.
- Photogenic: Based on the picture submitted. Quality will be included in this division.

Judges will observe a candidate's posture, how she sits, walks, models, the style she projects and her overall appearance and behavior. Judges will be looking for personality, individuality, imagination, versatility, creativity, and how the contestant presents a complete image and appearance.

SPEECH DIVISION

The purpose of this division is to select the young woman who scores the highest in:

Speech/Presentation: Candidate will deliver a 2-to-3-minute speech. Deductions may be taken for using notes/note cards. Props are not permitted. Speech topic will be given to the candidate by the Royalty Coordinator on the night of the mandatory parent and contestant meeting. A hard copy of the candidate's speech (or heavy outline) must be submitted to the Royalty Coordinator during your interview on the day of tryouts.

Impromptu Question: The Same question about the fair, rodeo and royalty will be asked of each candidate. Judges will score on candidate's ability to clearly state the information of the topic chosen. This will be done after the interview.

GENERAL INFORMATION

Judges will also look for candidates who:

1. Can conduct themselves in situations that require maturity, diplomacy, and leadership (ability to adapt to most situations).
2. Have a happy outlook on life, general sense of humor.
3. Demonstrate promptness in keeping Tryout schedules.
4. Possess the ability to Relate to people of all ages and abilities.
5. Show genuine interest in other people and noticeable courtesy in all situations.
6. Present herself to people in a positive manner.
7. Project her personality to people she may meet in a brief time span, formal situations, and/or before an audience in other activities.

RIDING DIVISION: The contestant will be judged on her riding ability, knowledge of horses, execution of the pattern, and following directions.

SCORING: Candidates must meet a minimum scoring standard of 75% (of the total overall score) to be considered for a position on the Asotin County Fair & Hells Canyon Rodeo Royalty.

Candidates should realize they could be Judged at any time during the Tryout whether formally or informally.

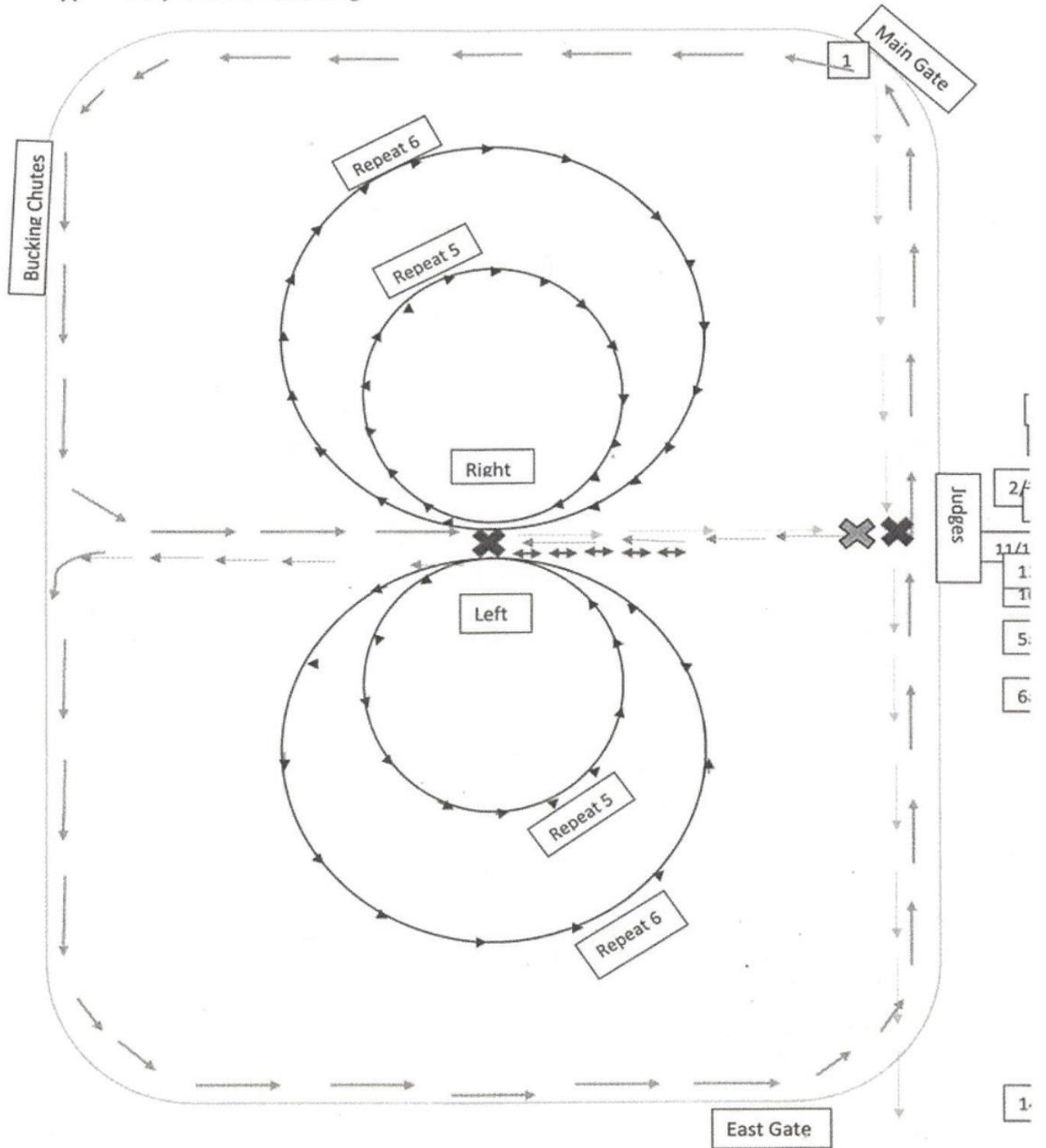

Riding Pattern Directions for Tryouts

- On foot walking your horse enter the arena at the gate by the announcer stand. Walk Down the fence line to where the Judge stands. Stop in Front of the Judge.
- Let the Judge inspect for proper riding equipment & bridle etc. Answer any question the Judge may ask.
- When the Judge is done inspection your equipment, mount your horse and walk to the center of the arena. Look Back at the Judge for the ok to start.
- Start your first circle to the right at a slow lope, making a small circle.
- Next make your second circle to the right a bigger one and at a faster lope.
- At the end of your second circle on the right ** Switch leads** and go to the left making your first circle a small circle at a slow lope.
- Next make your second circle to the left a bigger one and at a faster lope.
- After your second circle to the left ** stop in the middle of the arena** and back your horse 5-steps.
- After backing look back at the Judge for the ok to start your wall run.
- Once the Judge gives you the ok to start your wall run, **Walk straight ahead** to the opposite side of the arena from the Judge.
- Begin your wall run **To the Left** Don't forget to wave and smile, complete a full circle back to where you started stopping in the middle of the arena facing the Judge and Bleachers.
- Look at the Judge for the Ok to dismount. Once the Judge has given the ok to dismount walk your horse to the Judge and wait for the Judge to Dismiss you before leaving.
- Leave by walking your horse to the same gate you came in by the announcer stand.
